## VNA Health Care has completed over 11,000 Tests for COVID-19 and is ready to meet the increasing demand for community testing services during the anticipated surge in positivity rates.

This week, VNA surpassed 11,000 COVID-19 tests completed since the start of the pandemic. Testing at VNA is conducted using a nasal swab and is available to individuals with and without symptoms. Currently, results are provided within 2-3 days of the test.

"VNA was founded during the pandemic of 1918 and our commitment to delivering exceptional healthcare services, with a focus on caring for some of our most vulnerable neighbors in the communities we serve across the Chicago metro region, has endured throughout this century of service," said Linnea Windel, VNA President & CEO.

VNA offers a full range of primary care services that improve access to care for populations at increased risk of health disparities. These services are available in-person and also by telehealth. Getting tested provides an individual with important knowledge of their health status at that point in time and VNA recommends that individuals quarantine while awaiting their results.
